Policies

- If the program is conducted at the YWCA Elgin, students must arrive by **10:00am** or else they will not be allowed to stay at the YWCA Elgin that day or be dropped off where Take 2 is located (for example, Gail Borden Library or field trip location).
- If the program is conducted virtually via Zoom, students must be available from **10:00am-12:00pm** to meet with the class and discuss projects. They will be emailed/texted the meeting information.
- Students must be active participants in the **Take 2** program. They are expected to attend classes and complete assigned projects. If a student does not attend classes often and/or does not participate in projects, they can be dismissed from the program.
- If the program is conducted at the YWCA Elgin, students are responsible to sign in and sign out every day.
- Once the student signs out, they are not allowed to return that day.
- If the program is conducted at the YWCA Elgin, students must leave the building by 5:00pm.
- Students must respect all teachers, YWCA staff, and fellow classmates.
- Students must respect all equipment and the YWCA building.
- Students are allowed to use YWCA Elgin equipment under a teacher's supervision.
- Students are not allowed to take any equipment home.
- Students are not allowed to film or take photos of anybody without permission.
- Students are allowed to bring their personal electronics. However, personal electronics are **NOT** allowed to be used during class sessions. If the personal electronics become a distraction, they will be confiscated and returned at the end of the day.
- If any equipment is taken, damaged, or used inappropriately, the student will be held responsible and will be dismissed from the program.
- Students represent the YWCA Elgin in and outside of the building. If a student repeatedly behaves inappropriately, they can be dismissed from the program.
